Samish Tribe- Chief Noyes met with Samish tribe planning manager Ryan Walters and Emergency Manager David Strich to discuss future projects and collaboration that can be done. The tribe has a copy of the current contract between the tribe and the fire district and are working on updating the properties that the tribe owns in the district.

## **New Business-**

Washington State Department of Revenue-Stephanie met with Jon from Washington State Department of Revenue on January 6<sup>th</sup> to review the Districts Excise tax account. This is the tax the district pays on our rental properties. Jon reviewed everything for the last 5yrs, and the district overpaid by \$90. This amount will be applied to our account.

Hiring of full time Chief timeline, job description & employment agreement- Some discussion about timeline. Should we have the position in place before fire season possibly the first of June or January 1<sup>st</sup>, 2021, no decision made. Some discussion about job description, is the one the district currently has enough, or does it need some revising. The commissioners need to work on a salary & benefit package along with an employment agreement. Stephanie emailed out several job description and employment examples from districts in the area that have a full time chief in a volunteer district.
